

Work highlights

Client highlights include:

A sponsor licence is a valuable asset for any organisation as it facilitates the sponsorship of an overseas national to work or study in the UK.



In 2023, the Immigration Team obtained over 20 sponsor licenses for clients across our Faith, Education, Business and Charity sectors with a 100% success rate.

This is a complex application and involves detailed representations to the UKVI as to why the client cannot recruit from inside of the UK and how they meet the strict requirements. Upon obtaining the licence we continue to provide full support to the client through our Level 1 User service. Client highlights include: Diocese and Archdiocese, Multi-Academy Trusts, International learning partner to governments, large Further Education College, global hospitality business and a large Lutheran Church.



Work highlights

We have supported over 25 individuals with a range of complex private client immigration matters including, successfully assisting families seeking to relocate to the UK on a permanent basis under the family route. We regularly work with individuals who have previous visa refusals or complex financial or medical circumstances requiring us to argue exceptional circumstances under Appendix FM.

We also work with a number of high net worth individuals, such as successful actors with complex Global Talent Visas to allow them to permanently reside in the UK.

Julie continues to be a leading specialist in the sponsorship of religious workers within faith based organisations. The need for religious organisations to look at their succession and recruitment of members from outside of the UK for support has led to the rapid development of this niche area.

The team have supported almost 50 faith based organisations with their immigration matters last year which consist of both new and existing clients of the firm.

Work highlights

Last year we advised extensively on shortages in the workforce across the sectors, including care homes, healthcare providers, tech companies, faith organisations and MATs. A large part of our work is assessing whether a role is eligible for sponsorship, obtaining and assigning a Certificate of Sponsorship and thereafter preparing the visa application to ensure the immigration rules are satisfied.

In 2023 alone we successfully obtained over 30 Skilled Worker, T2 Minister of Religion and T5 Religious Worker visas for individuals seeking to work in the UK.
